The committee provided numerous opportunities for input to the Code.

We expect everyone to follow this Code so that you and other participants can enjoy the Event responsibly and with respect for the rights of others. Failure to abide by this Code is subject to corrective action and sanctions, including refused admission, ejection, banishment, and other penalties consistent with this Code.

Land Acknowledgement

Len Levin, a member of the DEI Committee read the Land Acknowledgement statement written to honor the grounds and indigenous people associated with the Phoenix meeting.

We recognize the land as an expression of gratitude and appreciation to those whose territory hosts our annual meeting and as a way to of honoring the Indigenous People who have been living and working on the land from time immemorial. It is important to understand the long-standing history that has brought us to visit this land. Land acknowledgments do not exist in past tenses, or historical context: colonialism is a current, ongoing process, and we need to build our mindfulness of our present participation. It also is worth noting that acknowledging the land is an Indigenous protocol.

There are 22 tribes living today in Arizona. The lands of four of these tribes are in and surround Phoenix. Please join me in thanking the:

- Gila River Community
- Pascua Yaqui
- and the Salt River Pima-Maricopa Indian Community

for their stewardship of the land and water, generosity in sharing the dessert with us and their knowledge and contributions to medicine. The people of these nations continue to live here and contribute to the vibrancy that is Phoenix through their contributions to health care, education, land stewardship, and local business.

Committee Highlights & Accomplishments

Membership is strong. AAHSL membership has grown to 182 members at this time among our membership categories.

The new Diversity, Equity and Inclusion Committee also collaborated with the MLA and the NNLMs to contract with Jessica Pettit to present 9 webinars on timely DEI topics. These are active and well-attended sessions.

The Competency-Based Medical Education Task Force, Phase 2 Task Force is chaired by Amy Blevins from Indiana University. The new task force is charged with surfacing the achievements of libraries which have embraced the AAMCs Core Entrustable Professional Activities, specifically, but not limited to EPA 7: Form Clinical Questions & Retrieve Evidence to Advance Patient Care. This is an opportunity for AAHSL to share successes with our partner organizations – AAMC, GIR, ADEA and IPEC. Their work began this fall.

The new liaison model for AAHSL representation and participation in the GIR (the AAMC Group on Information Resources) is working out very well. Megan Von Isenburg from Duke is our representative to GIR providing periodic briefings and presentations to the GIR Steering Committee. There is a common intersection with GIR around issues that touch on libraries, data science, EHRs, and providing services to growing affiliated health care organizations.

Matt Wilcox, Chair of the Assessment & Statistics Committee, along with Steve Squires, Editor, and the A&S Committee members, successfully rolled out the Annual AAHSL survey which includes outsourcing the collection, analysis, and reporting of the data to Counting Opinions on the LibPas platform. The Annual Survey, Salary Survey and Descriptive Surveys are being completed now. There were 136 responding libraries to the 41st annual survey. Of 187 known eligible libraries, this represents a 68% for the annual survey, a 69% response for the Salary Survey, and a 72% response rate overall. The responding libraries included 4 Canadian libraries and 14 separate libraries serving osteopathic medical schools.

There were several major changes in the Leadership Fellows Program this year. The structure of three major components was altered in order to provide a multi-day leadership institute with more in-depth coverage of topics and additional time for sharing experiences and exploring the role the HSL director. The curriculum content was reviewed and revised to provide a better continuum of learning and flow of topics throughout the year. As of September 13, 2019, the LFP has completed its revised Orientation, Leadership Institute, and Capstone events for the year.

Highlights of the year for Research Services Committee include the awarding of nine **AAHSL/NNLM Data Scholarships**. Committee members working with the AAHSL Board and the staff from the NNLM/PNR office developed a subcontract proposal to fund Data Scholarships. The purpose of the awards is to strengthen the professional knowledge and experience of individuals at AAHSL institutions to improve and to build professional capacity in support of research data knowledge. This scholarship provides those selected with an opportunity to attend or experience a professional development activity related to research data knowledge and receive up to \$2000.00 in support of that activity. There were 10 awardees.

The Committee also held a successful Publications Metrics and the Role of Academic Health Sciences Libraries Webinar last week. This was a follow-up activity based on the Research metrics survey conducted earlier this year. The webinar was a huge success with 131 sites hosting one or more people.

The Scholarly Communication is keeping the membership updated with a series of messages on issues related Open Access, scholarly publishing, publisher news and other topics gleaned from multiple sources – SPARC, Open Access Working Group. These messages provide links timely topics and keep us up to date on scholarly communications topics.

The Task Force on Library Services to Associated Clinical Organizations is co-chaired by Melissa DeSantis and Megan von Isenburg. The TF will be conducting interviews with select librarians – these were identified from those volunteering via the call for participation, those who attended the last year's informal meeting on the topic, and responses to the October 2018 survey from the co-chairs. Based on feedback received during upcoming interviews, an analysis of common features and variables of the funding models will be conducted. These will ultimately be shared with the membership.

Strategic Planning

There were several opportunities throughout the year for members to give input to a new AAHSL Strategic Plan. An in-person session at MLA was held, 2 Zoom calls over the summer, and a brief survey was posted to AAHSL-All. Over 50 members chose to participate in one of the sessions.

The major goals of the association were re-affirmed in the feedback received. These are concentrated in the following areas:

- 1. Professional leadership and development
- 2. Imagining the future
- 3. Promoting best practices
- 4. Advocacy
- 5. Strategic partnerships and collaborations
- 6. Fostering a community of colleagues
- 7. Enabling a diverse and inclusive association

One area of focus new to the goals is the need for improved, consistent communication with the membership. This will be explored during the coming year. The Board will be doing a deeper dive into the comments provided and will incorporate new objectives and action items which are most impactful.

Treasurer's and Headquarters Reports

Jerry Perry, Board secretary/treasurer, reported on the financials and membership of AAHSL. Membership has grown to 182. Full membership is up 4 from 2018; Canadian is up 1; Associate is up 2; New is down 3; and Developing up 5. Total membership in 2018 was 173.

Finances were:

Checking \$478,813
Savings \$122,458
Fidelity Brokerage Account \$206,940
1 Certificates of Deposit \$34,648
Total \$842,060

These numbers are better than last year because:

- 1) belt-tightening
- 2) Increase in dues revenue from Associates
- 3) Decrease in consultancy fees
- 4) Decision to spend less on scholarships, while still supporting IMLS/MLA Research Training Institute
- 5) Continued support from NLM for Fellowship Program

There were rumors that AAHSL was in financial trouble but that is untrue. However, expenses ARE rising for travel, meeting facilities and food; committees are asking for funds in new areas; and the board was committed to "living within our means."
